## AUDIT SUMMARY

### Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Pierce County Housing Authority from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Investments
- Open Public Meetings Act
- Procurement – bid law compliance
- Tenant fraud reporting
- Financial condition
- Travel and meal expenditures
- Payment in lieu of taxes

## INFORMATION ABOUT THE HOUSING AUTHORITY

The Pierce County Housing Authority was created to provide housing opportunities for eligible individuals within Pierce County. The Housing Authority owned and managed eight apartment complexes at the end of 2014. The Housing Authority also provides housing assistance through the Low Income Public Housing Program for citizens of Pierce County.

An appointed, six-member Board of Commissioners governs the Housing Authority. Five Commissioners are appointed by the Pierce County Executive, and a housing resident is appointed by the Board. The Board appoints an Executive Director to oversee the Authority's daily operations as well as its approximately 40 employees. For fiscal year 2014, the Housing Authority operated on an annual budget of approximately \$28 million.
