Under RCW 42.30.110, an executive session may be held for the purpose of receiving and evaluating complaints against or reviewing the qualifications of an applicant for public employment or reviewing the performance of a public employee; consultation with legal counsel regarding agency enforcement actions, or actual or potential agency litigation; considering the sale or acquisition of real estate; and/or reviewing professional negotiations.

11:34 AM Chairperson Smith described today's strategic planning process, as described by the Strategic Planning Committee, as engaging in an analysis of Strengths, Weaknesses, Opportunities, and Threats related to the internal and external operating environment of the Pierce County Housing Authority and informed commissioners that:

- Strengths: are of internal attributes of an organization and viewed as helpful.
- Weaknesses: are also internal attributes of an organization and viewed as harmful.

- Opportunities: are of external origin and considered helpful
- Threats: are of external origin and considered as harmful.

Chair Smith invited commissioners to use sticky notes for the purpose of identifying strengths, weakness, opportunities and threats relevant to the mission of the Pierce County Housing Authority: The provision of safe decent, affordable housing and economic opportunity, free from discrimination.

Each member individually wrote examples of SWOT on sticky notes and placed them under the heading strengths, weakness, opportunities and threats.

Ellie Ottey, Deputy Executive Director then read each sticky note out loud.

Chairperson Smith then asked individual commissioners and staff to use a magic marker to check those items that felt most critical. Commissioners did so.

Chairperson Smith then read aloud the sticky notes that had received check marks.

Charlie Gray, Executive Director announced that staff would record the results of the SWOT analysis and attempt to group similar items in order to inform future work of the BOC. Charlie also announced that he would engage housing authority staff in a similar exercise and provide the results of that exercise to the BOC if requested.

Chairperson Smith adjourned the meeting at 3:40 PM
